Subject: CDL — Mexican License Design and Interpretation

Verify the validity of **All** MX CDL's using the [General Directorate of Federal Motor Transport](https://www.gdftm.gob.mx/) website **only**.

Other addresses listed below may assist if looking up by the CURP/Med

LFC Card Type 1



Should not see type 1 any longer.

- There are two physical cards that may be encountered through 2025.
- Type 1 was the first to phase out on January 15, 2023.
- Any LFC card with an issue date after April 1, 2021 is likely fraudulent.



Types of Fraud (Physical LFC Cards)



Look for incorrect information using the [General Directorate of Federal Motor Transport](https://www.gdftm.gob.mx/) website.



A website address, other than that listed here, is a good indicator that the license is fraudulent. Always use the website above to verify.

A fraudulent license would result in a violation of 383.23A2 and the driver should be placed OOS.

All CDL's are valid for no more than 4 years. Verify the issue/expiration dates.

General Security

- Nationality other than Mexico is very rare. **Nacionalidad: MEXICO**
- First 304 characters of license number are state abbreviation where issued. See list below. **SON9876543**
- Physical license issued after April 1, 2021 will use "LFD" for state abbreviation.
- The CURP is 18 characters in length and unique, like SSN. **CURP: IACP171118HSKBRD14**
- Licenses are valid for up to 4 years.

LFC Card Type 2



All type 2 cards due to expire by March 31, 2025.

Type 2 Physical LFC Card Security

- Photo of driver (correct person).
- Laminated with refractive designs. No peeling.
- Micro line design. No blurring.
- SCT seal should overlap driver photo.
- Refractive seal of Mexico.
- Folio indicates number of times license issued / printed.
- Verification website displayed on back of physical LFC.

Federal Digital Driver License (FDDL)

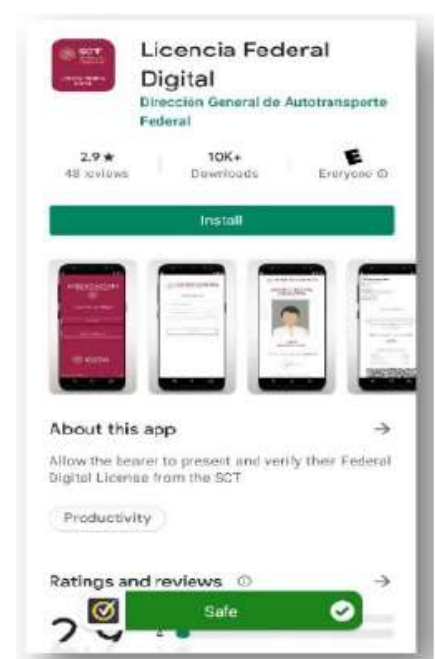
All LFCs are now issues in a digital format that can be viewed on the driver's phone or tablet.

- If presented with a digital version, **ensure you view the FDDL through the app** on your device.
- Do not accept a screenshot that was saved from the app. **Screenshots can be easily altered!**

The SCT's Driver App can be downloaded from the major app stores under the name "Licencia Federal Digital".



Federal Digital Driver License — Printed



Mexico allows drivers to print their LFC on paper. The printed version:

- Will have a date that it was accessed.
- **Is valid for only 30 days from the print date!**

Printed records older than 30 days will be considered to have no valid driver's license in possession in accordance with local laws.

- Cite 392.2 in the U.S. for local laws if the license status indicates "licensed" but is not in the driver's possession at the time of inspection.



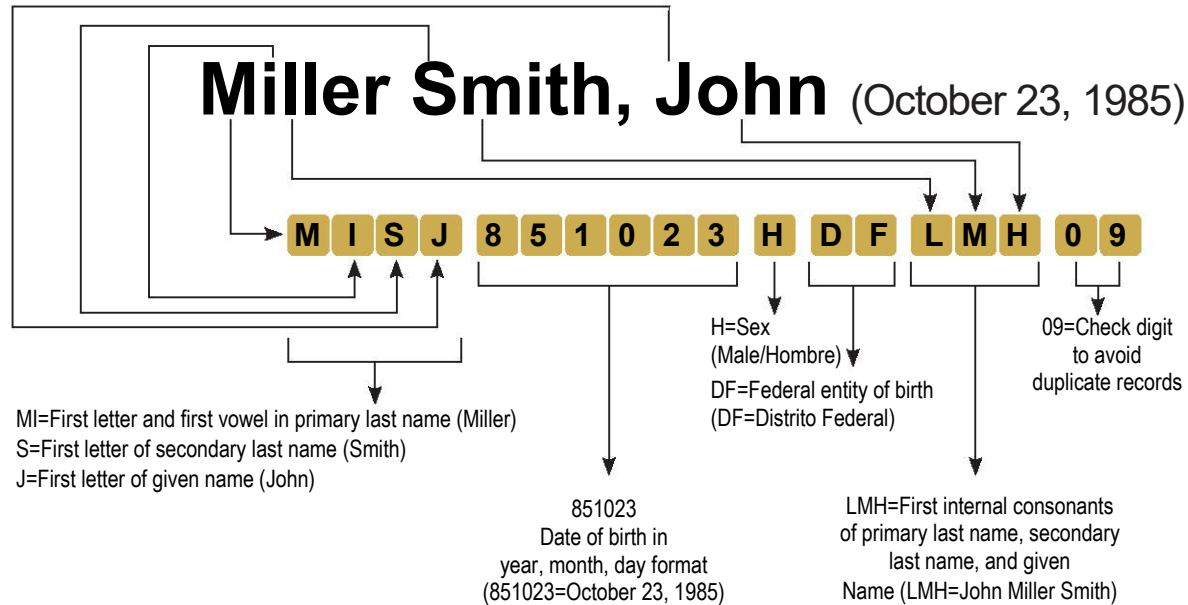
Drivers without the App are allowed to print a copy of the LFC.

Verify the validity of the LFC on the web site. No valid return equals 383.23A2 – No CDL. The driver should be placed OOS.

Date that the copy was printed will show on the record.

If more than 30 days old but license has been verified as valid on the website, apply violation of 392.2 – failing to carry license on person. This is not an OOS.

Understanding the CURP Number



Note: When there is only one last name, an “X” is used in place of the secondary last name initial. Middle name initials are not used.

Example: John Mark Miller = MIXJ

CURP Highlights

- The CURP is 18 characters in length and unique, like SSN.
- Federal Entity of Birth characters 21-13 do not correspond to state abbreviation table.
- Characters 14-16 are frequently incorrect on fraudulent licenses.
- Last two characters are check digits. Drivers born before 2000 will contain numbers 0-9. Drivers born after 2000 will contain characters A-Z.
