



REQUIREMENTS

Temporary Stay Visa



Sixty (60) days.

The request for a Temporary Stay Visa must be accompanied by the following documents:

ORIGINALS OF ALL DOCUMENTS MUST BE SUBMITTED TOGETHER WITH PHOTOCOPIES (ONE COPY PER DOCUMENT).

- 1 Applicant's letter requesting the visa, addressed to the Consulate General of the Republic of Angola in the United Kingdom, signed by the applicant, stating the reasons for the trip and specifying the intended length of stay. The signature must be made in the presence of the consular officer and recognised at this Consulate General (template).
- 2 Form duly completed in black ink, in block capitals or typed, without errors or corrections - Attach photograph to the form.
- 3 Passport valid for more than six (6) months, with at least two (2) consecutive blank pages for the visa stamp - Please photocopy the main pages and any pages containing migration information.
- 4 Three (3) passport-type photographs, in colour, white background, taken no more than 3 months ago, without sunglasses (unless medically required). Male applicants must not have earrings, braids or a mohawk.
- 5 Criminal Record Certificate with a validity of no more than six (6) months, translated into Portuguese by an official translator, recognised by a Public Notary, authenticated by the FCO (Foreign, Commonwealth & Development Office) and by this Consulate General.
- 6 Medical Certificate issued by the Health Centre, confirming the absence of any infectious or contagious disease. The certificate must be translated into Portuguese, recognised by a Public Notary, authenticated by the FCO (Foreign, Commonwealth & Development Office) and by this Consulate General.
- 7 International Vaccination Certificate.
- 8 Proof of Means of Subsistence.

- 9 Proof of Accommodation Conditions.
- 10 **Return Travel Itinerary to the Republic of Angola: airline or travel agency reservation.**
THE PURCHASE OF A TICKET IS NOT REQUIRED AND POSSESSION OF A TICKET DOES NOT JUSTIFY THE GRANTING OF A VISA.
- 11 Declaration of Commitment to comply with the laws in force in the Republic of Angola, with signature recognised by a Public Notary and authenticated by this Consulate General (template).
- 12 Proof of family or employment ties with an Angolan or foreign national/company legally residing/established in the country.

FOR MINORS (under 18 years of age)

In addition to all documentation listed above, the following documents must also be submitted:

Complete Birth Certificate of the minor.

Photocopy of the Parents'/Legal Guardian's Passport.

IF TRAVELLING WITH ONLY ONE PARENT (FATHER OR MOTHER):

Travel Authorisation from the non-travelling parent, with signature recognised by a Public Notary. In the case of an Angolan parent, the signature must be made in the presence of the consular officer and authenticated by this Consulate General (template).

IF TRAVELLING WITHOUT PARENT(S) OR LEGAL GUARDIAN:

Travel Authorisation from the parent(s) or legal guardian, with signature recognised by a Public Notary. In the case of Angolan parent(s), the signature must be made in the presence of the consular officer and authenticated by this Consulate General (template).

Travel itinerary of the accompanying person.

Passport of the accompanying person.

NON-ANGOLAN PARENTS OR LEGAL GUARDIANS MUST ISSUE A TRAVEL AUTHORISATION IN PORTUGUESE OR TRANSLATED INTO PORTUGUESE AND HAVE THE SIGNATURE AUTHENTICATED BY A PUBLIC NOTARY.
