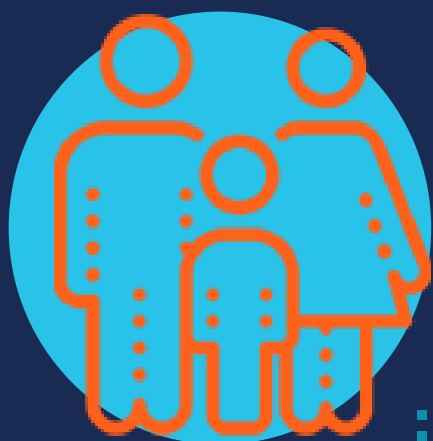




QATAR TOURIST VISA CHEAT SHEET

QATAR E-VISA REQUIREMENTS

Note: Qatar E-visa is till suspended, and you may not apply for it. Wait until further notice.



YOUR PASSPORT

A scanned copy of the bio or picture page is needed. Bear an essential point to your mind. Your passport must be valid for at least 6 months from the date you enter Qatar.



A PASSPORT-SIZE PHOTO OF YOURSELF



A PURCHASED AIRLINE TICKET

Remember one point. If you're a passenger of Qatar Airways, you won't need to submit a ticket copy.



THE HOTEL CONFIRMATION VOUCHER OR RESERVATION.

Submit the documents for the place you'll stay in Qatar.

In case you are a national of the GCC, Gulf Cooperation Council:

1. Bahrain ·
2. Kuwait ·
3. Oman ·
4. Qatar ·
5. Saudi Arabia ·
6. And United Arab Emirates.

You must provide

1. GCC resident visa
2. GCC ID card
3. Your sponsor ticket and passport copy

QATAR VISA ON ARRIVAL ELIGIBILITY

No 1. You must be a national of the approved countries.

Only nationals of these countries can get visa on arrival.

You must have a passport from them/

No 2. is the validity of your passport.

It must be valid for at least six months at the time of application.

No 3. Is a confirmed return ticket to your home country or another destination.

You must show that you intend to leave Qatar after the visa expiry.

No 4. Is the hotel reservation.

You should reserve your hotel before getting to Qatar and show the proof to the officials at the port of entry.

The reservation can be with any place or through any agent you want.

But the citizens of India, Pakistan, and Iran must reserve a hotel through the Discover Qatar website.

You can find the link in the description.

No 5. is receiving Ehteraz pre-approval.

Travelers must register on the Ehteraz website before getting to the country.

The approval is required to get the visa on arrival.

No 6. Covid-19 test to get on the flight.

No 7. is proof of having enough funds for your stay in Qatar.

It applies to the nationalities of a few countries like India and Pakistan.

The least required fund is 5.000 Qatari Riyal, the country's currency, on your credit or debit card.

For debit card holders, a 3 months bank statement is also required.

The card must be under the traveler's name or the family head.

When you apply for Ehteraz registration, the photo of the credit card and bank statement must be uploaded.

QATAR E-VISA APPLICATION

Sign up or sign in with your email address and password.

Complete the forms with your basic personal information:

1. Name

2, nationality

3. Date of birth

4. And contact details.

Pick the duration of stay you want.

The system will provide the appropriate visa with the provided information.

Then, you must submit the scanned form of the documents I mentioned earlier.

After that, you will be directed to the online payment page.

The system only accepts payment from a Visa or Mastercard debris or credit card.

It might change in the future.

No one knows.

After the payment, you'll get the status update in your email address.

After 48-96 hours, you'll get the response or your Evisa in your email address.

You'd better apply as early as possible for your Evisa.

Bu the latest time you can apply is 4 days before your entrance date, and the earliest time is 90 days before your trip.

The responsible center for E-visa processing is VFS Global.

They complete all the processes from A-Z.
