

MARRIAGE IN ITALY

of an Italian citizen with a foreign partner

All Italian citizens, before marriage must make the publication of marriage (marriage bans). On the contrary, foreign or Australian citizens who marry in Italy need some documents that will be necessary to obtain a specific Nulla Osta (permit) issued by their Embassy in Italy. For citizens registered with AIRE (Italian Register of Residents Abroad) marriage publications must be made at this Consulate. For residents in Italy - not registered AIRE - but who are temporarily living in Australia, this Consulate will make requests for publications to the Municipality where the applicant resides. For those wishing to marry with a religious rite with civil value (concordat), the Italian parish priest will have to send to the Consulate a specific request for marriage publications according to a specific model.

MARRIAGE PUBLICATIONS

To request marriage publications, the presence of both applicants is required without prior appointment of the applicants, to sign the [request form for publications](#) in front of the consular authority.

The foreign citizen must also bring:

- Original birth certificate
- Single Status Certificate or Atto Notorio (see specific indications)

Please note: Citizens of countries belonging to the European Union do not need a Single Status Certificate

After having posting the wedding publications for 8 days, this Consulate will issue a certificate of successful marriage publications which will be sent by certified mail to the relevant Municipality.

ATTO NOTORIO FOR AUSTRALIAN CITIZENS

Australian citizens need a ATTO NOTORIO, signed by the future spouses and four (4) witnesses, in which they declare that there are no impediment to the marriage pursuant to articles 95, 86, 89 and 97 of the Italian Civil Code.

The atto notorio can be obtained in Australia at the Consulate competent for the State of residence, or in Italy at any Tribunal. Applicants and witnesses must be all present on the day of the appointment. The spouses can use the same witnesses if both need a Atto Notorio.

The Atto Notorio must be presented to the Australian Embassy in Italy in order to obtain the NULLA OSTA, pursuant to article 116 of the Italian Civil Code. [Cost of the Atto Notorio](#) (cash or debit card).

In order to obtain the atto notorio at the Consulate of Italy in Adelaide, the applicants must book an appointment through the online booking system di [prenotazione online - notarile](#) and provide, at least two weeks prior the appointment, all the required information and personal details listed in the attachment relating to the personal details.

For the procedures to be followed in Italy, please follow the information on the website (<http://www.italy.embassy.gov.au>), Australian Citizens who wish to get married in Italy need:

1. Birth certificate in original bearing the Apostille issued by the “Department of Foreign Affairs and Trade” and official translation in Italian (www.naati.com.au);
2. Single Status Certificate (issued by the Registry of Births, Deaths and Marriages), bearing the Apostille by DFAT and official translation in Italian;

CITTADINI NON AUSTRALIANI

The only formality required once arrived in Italy is to request the Nulla Osta to the marriage at the competent Embassy. This Nulla Osta must then be handed over to the Municipality where the marriage will take place.
