- Do not use nicknames in Spouse or Parents' Name fields
- If full legal name includes multiple last names, even if not commonly used by the applicants and/or parents, provide all names

MARRIAGE OFFICIATORS:

After completing boxes 46-53, the signed license must be returned to the Registrar of Vital Records in the town of marriage, by the person who joins parties in marriage, within the first week of the month next succeeding such marriage.

DO NOT GIVE TO THE COUPLE TO RETURN TO TOWN OF EVENT. OFFICIANT IS RESPONSIBLE FOR DELIVERING COMPLETED FORM TO THE TOWN.

TOWN/LOCAL VITAL RECORDS REGISTRARS:

For persons under the supervision or control of a conservator, no marriage license may be issued until you receive a notarized affidavit signed by the conservator which states they consent to the marriage.

The notarized affidavit must be accompanied by:

- A certified copy of a current valid conservator of person court order; and
- A copy of a valid government issued ID for the named conservator of person.
