

ENROLLMENT DECLARATION - STUDENT

Further to my Enrollment at International Schooling, I, as a student, hereby declare and agree to the following that:

- I am enrolling here and the decision to enroll here is completely mine and that all the information provided by me (or that shall be provided by me in future) anywhere to International Schooling is true to the best of my knowledge without any exceptions and under no circumstances or cases whatsoever will I provide any information that is false, incomplete or misrepresented and all such similar cases where the information provided by me does not represent actual facts, then International Schooling has the right to take any action which they feel is appropriate.
- The enrollment or any other part of my grade/class/course/program shall be considered incomplete/invalid unless the accompanying and prescribed fee for those programs/courses or parts thereof have been received by the relevant authorities of International Schooling and confirmation regarding the same has been issued to me.
- I may be asked to provide additional information, proof, material in support of the information provided by me (especially related to but not limited to academic credentials, coursework, and other relevant information in support of my eligibility/candidature with International Schooling) especially if the information provided by me is incomplete, inconsistent (or with discrepancies) or not as per the prescribed requirements of International Schooling.
- I will not receive my transcript of the current academic year until and unless the transcript of my previous grade is submitted.
- I will not misrepresent any facts or details to International Schooling and not forge/misrepresent any documents, signatures, or credentials and any deviation from the above (or from any other truthful representation of details) shall render my candidature to be canceled (null/void) by International Schooling with immediate effect upon discovery of such misrepresentation(s).
- All the document(s) or their copies provided by me regarding any information whatsoever are true and correct and all the documents have been issued by the relevant and respective authorities, departments, and offices (government or private as the case may be from document to document).
- I completely understand that all the information relevant to my successful completion grade/class/course/program is provided on the collaterals of International Schooling from time to time and that it shall be my responsibility to read all the rules, regulations, policies, procedures and all other information provided by International Schooling on its platforms, systems and follow all of them in totality.
- The fee paid for the Connect to Impact program is separate from all other fees (included but not limited to course fee, enrollment fee) and is non-refundable/non-transferable/non-adjustable.
