1. CHILDREN BELOW 1 YEAR OF AGE DO NOT REQUIRE A YELLOW FEVER CERTIFICATE
2. PLEASE ENSURE YOUR PASSPORT IS SIGNED.
3. APPLICANTS ARE ENCOURAGED TO SUBMIT THEIR APPLICATIONS IN PERSON
4. FOR GROUP APPLICATIONS, KINDLY PROVIDE COPIES OF SUPPORTING DOCUMENTATION TO EACH APPLICATION.
5. ADDITIONAL DOCUMENTS REQUESTED AFTER SUBMISSION OF AN APPLICATION SHOULD BE DELIVERED TO THE SOUTH AFRICA HIGH COMMISSION OFFICES ON LENANA ROAD.

➤ Proof of a valid work/Study visa of the person ➤ Copy of Marriage Certificate (Original to be presented for proof) for married people. ➤ Proof of consent from both parents and birth certificate of the child (Original Birth Certificate to be presented for proof) in case of minor children/child. ➤ Proof of undertaking in terms of Current three month Bank Statement from either applicant / Spouse or parent (Certified by the bank)		➤ Proof of medical cover renewed annually for the period of stay with a medical scheme registered in terms of the Medical Schemes Act;(South African), in case of families to join existing medical cover for principal applicant. ➤ A police clearance certificate from all the Countries he/she lived in since the age of 18yrs for 12 months or longer (Not applicable for applicant under the age of 18 years) ➤ Medical and radiological report in respect of applicant and all members accompanying him/her, except pregnant women and children younger than 12 years.
